An answer is a short statement that directly answers each and every the allegation made in the complaint with generally one of three responses: (1) "Admitted", (2) "Denied"; or (3) Lack knowledge or information sufficient to admit or deny.

### **How to Draft an Answer to a Debt Collection Lawsuit in 3 ...**

A summons for eviction of a rental property gives you only five (5) working days to file your answer with the court. Count five days starting with the day after you are served the summons. So for example, if the summons was served on you on a Tuesday, the first day would be Wednesday. Do not count Saturdays, Sundays, or legal holidays.

## **Answer to Civil Summons & Complaint in Florida**

A written answer to a summons can include several options:  
Denial: You can deny the allegations of the plaintiff's complaint. The plaintiff has to prove everything you deny. Admission: You can admit certain information. Anything admitted is not in dispute and the plaintiff does not have to prove it at trial.

## **How to Respond to a Small Claims Summons - dummies**

Example. The complaint gives the wrong birthday for a child. You can say, "I deny that Rafe's birthday is 3 November, 2008. Rafe's birthday is 13 November, 2008." Where do I get an Answer form? The only official court answer form is the Answer to Divorce. You can get it from the Probate and Family Court. There is no "official" court answer form for any other complaint.

### **Responding To A Complaint If You've Been Sued - Civil Law ...**

In Georgia, the Summons will usually say something like "If you fail to do [answer], judgment by default will be taken against you for the relief demanded in the complaint." In other words, if you fail to file an answer, the creditor will get a default judgment against you without having to prove their case.
